

INCORPORATION OF THE ECONOMIC DEVELOPMENT CORPORATION

ORDINANCE NO. 117

An ordinance approving the incorporation of the economic development corporation of the City of Munising.

PREAMBLE

Whereas, there exists in the City of Munising the need for certain programs to alleviate and prevent the conditions of unemployment, to assist and retain local industries and commercial enterprises to strengthen and revitalize the City's economy; and

Whereas, it is therefore necessary to provide the means and methods for the encouragement and assistance of industrial and commercial enterprises in locating and expanding in the City, to more conveniently provide needed services and facilities of such enterprises to the City and its residents; and

Whereas, Act 33 of the Public Acts of Michigan, of 1974, as amended ("Act 338") provides for the incorporation of an economic development corporation for the City to accomplish such purposes; and

Whereas, an application has been filed pursuant to Act 338 of the Public Acts of Michigan of 1974, as amended, for permission to incorporate an economic development corporation for the City; and

Whereas, a public hearing on said application and any competing application has been held.

The City of Munising Ordains:

Section: 1.

The application under date of April 17, 1978, filed by Michael K. Mikulich, Richard William Nebel, and Robert A. Schewyen to incorporate the Economic Development Corporation of the City of Munising and proposed Articles of Incorporation for said corporation be and the same are hereby approved and adopted.

Section: 2.

The Articles of Incorporation shall be executed in duplicate and upon execution the City Clerk be and is hereby directed to file and publish said Articles in accordance with Section 31 of Act No. 338.

Section: 3.

The City Clerk be and is hereby further directed to publish this Ordinance once in the Munising News, a newspaper of general circulation in the City of Munising promptly after the passage of this Ordinance and after said publication record said Ordinance in the Record of Ordinances and certify that in said Record of Ordinance the time and place of such publication

Section: 4.

Upon passage of this Ordinance and its entry in the Record of Ordinances, the Mayor and City Clerk are hereby directed to authenticate the same by their official signatures upon said record.

Section: 5.

All Ordinances and parts of Ordinances inconsistent with the provisions hereof be and are hereby repealed, revoked and rescinded.

Section: 6.

In conformity with Act 338, this Ordinance shall become effective immediately after its publication and recordation.
