ELECTION PRECINCT  
ORDINANCE 2011-1

An Ordinance to establish the one (1) election precinct in the City of Munising, Michigan.

THE CITY OF MUNISING ORDAINS:

SECTION 1. Whereas, it is the duty and responsibility of the City Election Commission and the City Commission, pursuant to the provisions of Chapter 3, Section 3.3, of the City Charter of 1978, to provide for convenient election precincts;

SECTION 2. Whereas, the one man, one vote principle has been applied to representation on the County Board;

SECTION 3. Whereas, this action resulted in the apportionment of the City into two (2) separate County Supervisor Districts; and

SECTION 4. Whereas, pursuant to MCL 168.858, the City may consolidate all election precincts into one precinct and both the Election Commission and City Commission determine it is in the best interest of the City to so consolidate.

SECTION 5. Therefore, a single election precinct is hereby established for the City of Munising, Michigan, at the City Hall Building, for Both County Commissioner District No. 2 and County Commissioner District No. 3.

SECTION 6. Ordinance No. 7, adopted March 15, 1993, is hereby repealed.
