- A. CALL TO ORDER OF SPECIAL CITY COMMISSION MEETING, PLEDGE OF ALLEGIANCE, ROLL CALL

The Special Meeting of the City Commission was duly called and held on Monday, **July 28, 2008**, in the City Commission Meeting Room of City Hall. Mayor Pro-Tem Lovellette called the Special Meeting to order at 3:00 p.m.

- B. BOARD ALTRAN BUS - INSPECT TREES AND SIDEWALKS OF CONCERN IN THE CITY

Also present was City Manager Bovin and Terry Janssen of Mead & Hunt, all boarded the ALTRAN bus and reviewed trees and sidewalks of concern. Several streets will need trees removed possibly replanting can take place next year. There are several trees that need to be cut down they are causing sidewalks to break up, there are also root problems, some stumps may not be able to be removed due to gas lines and such. Terry Janssen of Mead & Hunt stated that the curb and gutter contractors have indicated that they may start next week and would be able to accomplish a half mile per week. The first trees to be affected would be along Maple St., the 200-300 blocks of E. Chocolate St., the 100-200 blocks of E. Onota St. Once back in the City Commission meeting room the following motions were made.

Moved by Commissioner Bornslaeger to authorize the City Manager to get quotes to cut and or grind trees in the area where Bacco is prepared to lay curbing, authorizing up to \$50,000.00 of leachate funds to pay for the tree removal. Supported by Commissioner Beauprey.

Both Commissioner Bornslaeger and Commissioner Beauprey withdrew the motion and support.

Moved by Commissioner Bornslaeger to allow the City Manager to seek pricing on tree removal where Bacco is laying curbing, the City Manager is to bring back information by the August 6, 2008 meeting. Supported by Commissioner Beauprey.
